- f) Minimum salary amount for the definition of this amount, please note there are different requirements according to Portuguese Law. Normally, an annual amount of € 25.000 does not raise questions with SEF.



The D7 Residence Visa was conceived for the following groups of applicants:

- a) Retired foreign citizens;
- Foreign citizens who live from income from movable or immovable property or from intellectual property;
- c) Foreign citizens who live from income from financial investments;
- d) Foreign citizens earning their own income as freelancers, for example.

By the time of the SEF appointment, the applicant must be physically present in Portugal to submit remaining documentation and to collect biometric data.

The residence permit/card is issued in Portugal according to the type of visa granted and is valid for a period of 2 years, renewable for 3 years.

Requirements / Documentation

Depending on the country of origin, the visa request may be submitted **online** (E-Visa Portal), at the Consulate or external service provider (**VFS Global**) of the area of residence, with the following general documentation (all documents must be translated to Portuguese):



Valid identification documents: ID card from country of origin, 2 photographs and proof of residence in the country of origin (e.g.: lease agreement, public deed of purchase of property or utility bills);



Valid travel document: Passport² (original document as well as integral copy of all pages);



Reservation of the round trip flights;



Authorization for SEF to consult Portuguese criminal record:



Letter explaining the reasons tomove to Portugal;



Criminal record³ - Apostilled or notarized, duly translated to Portuguese (the translation also notarized and apostilled);

² The passport must be valid for more than 3 months, after the visa expiration date.

³ The criminal record certificate shall have been issued for less than 90 days by the competent authority from the country of nationality or of the country where the applicant has been living for more than 1 year.



- a) Citizens that receive incomes from work contract or service agreement with a minimum amount of 3.040,00 € per month;
- b) Activity is exercised in a remote basis.

By the time of the SEF appointment, the applicant must be physically present in Portugal to submit remaining documentation and to collect biometric data.

The residence permit/card is issued in Portugal according to the type of visa granted and is valid for a period of 2 years, renewable for 3 years.

Requirements / Documentation

Depending on the country of origin, the visa request may be submitted **online** (E-Visa Portal), at the Consulate or external service provider (**VFS Global**) of the area of residence, with the following general documentation (all documents must be translated to Portuguese). The application may also be submitted without the previous submission of the visa in the embassies (through an appointment in Portugal).
